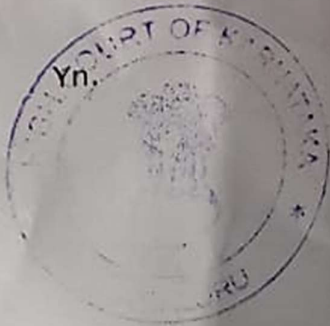


3. Learned advocates on both sides agree that parties may be relegated to NCLT.
